- COVER:** The Insurer shall, on the occurrence of an Insolvency Event during the Policy Period, pay to the Insured for the benefit of Claimants, an amount equal to the Ultimate Net Loss of each Claimant subject to the terms, conditions, exclusions from and limits of liability set out in this Policy.
- SUM INSURED:** Up to EUR 500,000 per Claimant, subject to and in accordance with the limits and the terms and conditions of the Policy.
- RETENTION:** In respect of each Claimant the sum of all Distributions and Deemed Distributions pertaining to that Claimant, subject to a minimum of EUR 20,000 each claimant.
